#### BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. This ordinance makes a supplemental appropriation not to exceed \$28,160,000 to the Harborview building repair and replacement fund.

SECTION 2. Ordinance 18397, Section 2, as amended, is hereby amended by adding thereto and
