service within Lake Forest Park city limits.

4. An agreement relating to the provision of these duties is authorized by the Interlocal

Cooperation Act, chapter 39.34 RCW.

## BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The county executive is hereby authorized to enter into a interlocal agreement,

substantially in the form attached, with the city of Lake Forest Park for the county to provide fire investigation services within Lake Forest Park city limits.
