BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

<u>SECTION 1.</u> Findings. The council makes the following findings.

- A. The metropolitan King County council adopted and ratified the Growth Management Planning Council recommended King County 2012 Countywide Planning Policies (Phase I) in July 1992, under Ordinance 10450.
- B. The metropolitan King County council adopted and ratified the Phase II amendments to the Countywide Planning Policies on August 15, 1994, under Ordinance 11446.
- C. The Growth Management Planning Council met on July 24, 2002 and voted to recommend amendments to the King County 2012 Countywide Planning Policies, revising existing policies and adding new policies to support extending household and employment targets for the period 2001 through 2022.
- D. The Growth Management Planning Council met on September 25, 2002 and voted to recommend amendments to the King County 2012 Countywide Planning Policies, adopting new household and employment targets for the period 2001-2022.

SECTION 2. Ordinance 10450, Section 3, as amended, and K.C.C. 20.10.030 are each hereby amended to read as follows:
