BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

<u>SECTION 1.</u> This ordinance makes a supplemental appropriation of \$16,399,896 to the public transportation infrastructure capital fund.

SECTION 2. Ordinance 18409, Section 132, as amended, is hereby amended by adding thereto and inserting the following:
