AN ORDINANCE approving and adopting the collective bargaining agreement and memorandum of agreement negotiated by and between King County and International Brotherhood of Electrical Workers, Local 77 (Transit) representing employees in the department of transportation; and establishing the effective date of said agreements.

STATEMENT OF FACTS:

The signature pages of the collective bargaining agreement and memorandum of agreement that are approved by this ordinance (Attachments A and C to this ordinance) are incorrectly dated January 6, 2011. County council staff has been informed by county executive staff that the documents were signed on January 6, 2012, but that through an oversight the printed year was not changed from 2011 to 2012 when the documents were signed. Executive staff has further informed council staff that the agreements will be modified by the parties to reflect the correct date of signature.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The collective bargaining agreement and memorandum of agreement negotiated by and between King County and International Brotherhood of Electrical Workers, Local 77 (Transit) representing employees in the department of transportation and attached hereto are hereby approved and adopted by this reference made a part hereof.

SECTION 2. Terms and conditions of said agreements shall be effective from January 1, 2011, through and including December 31, 2014.
