STATEMENT OF FACTS:

1. Rainier Biogas LLC filed an application for a new sewer franchise to operate and maintain an

exclusive, tightline sewer pipeline for the purpose of transporting cow manure under King

County road rights-of-way, in council district seven.

2. The utilities technical review committee has approved Rainier Biogas LLC's franchise

application and acknowledges that it does not require further utilities technical review committee approval under K.C.C. 6.27.060 and 13.24.010.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

<u>SECTION 1.</u> The King County council, having determined that Rainier Biogas LLC's application meets the criteria for the granting of a sewer franchise and that said granting is in the best interests of the public, does hereby approve the franchise agreement set out in Attachment A to this ordinance and authorizes the King County executive to execute the same in substantially the same form as Attachment A to this ordinance.

SECTION 2. If within forty-five days after the granting of this franchise, the applicant shall have failed to sign the written acceptance incorporated herein, then the rights and privileges granted herein shall be forfeited and said franchise shall be null and void.
