AN ORDINANCE relating to the annexation of approximately 4.61 acres of land

into the Midway sewer district, known as the Westwood Sewer BLA Annexation,

for the purpose of sewer service.

## STATEMENT OF FACTS:

1. A notice of intention proposing the annexation of approximately 4.61 acres of land into the

Midway sewer district, known as Westwood Sewer BLA Annexation, for the purpose of

providing sewer service was filed with the county council on January 31, 2014.

2. Midway sewer district has found the petition for transfer to be sufficient and has concurred

with the proposed transfer in Resolution No. 2013-13, passed on September 11, 2013.

3. The Southwest Suburban sewer district has approved the transfer in Resolution 2013-03 approved on October 15, 2013.

4. The utilities technical review committee recommended county council approval of the proposed annexation.

5. The county council held the legally required public hearing and has considered the criteria in RCW 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

<u>SECTION 1.</u> The annexation of approximately 4.61 acres of land into the Midway sewer district for the purpose of providing sewer service described in Attachment A to this ordinance is approved. Approval of this proposed annexation is consistent with RCW 57.02.040.

SECTION 2. The Midway sewer district is the appropriate entity to serve the area proposed to be annexed.

SECTION 3. Completion of this annexation does not constitute county approval

or disapproval of any other permits, certifications or actions necessary to provide service to this annexation area.
