executive to transmit a motion and report regarding involuntary treatment act court by February 28, 2014, and

WHEREAS, the report provides an analysis of the cost of constructing and operating a two or three

courtroom facility located in a renovated Harborview Hall, and

WHEREAS, the report provides an analysis of the cost of constructing and operating one or two courtrooms located at Harborview Hall and one courtroom located at Fairfax Hospital, and

WHEREAS, the report provides an analysis of the impact upon the patients, family members and nonfamily member civilian witnesses served by the court in each at Harborview Hall and Fairfax Hospital, and

WHEREAS, the report provides a description of business process changes, including the use of video technology, that could reduce costs at involuntary treatment court, and

WHEREAS, the report provides an analysis of significant impacts including, but not limited to, impacts to the courts, prosecuting attorney's office, public defenders, courthouse security and mental health professionals of operating a satellite court at Fairfax Hospital;
