AN ORDINANCE adopting and ratifying Growth Management Planning Council

Motion 14-4.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Findings:

A. Growth Management Planning Council Motion 14-4 recommends approval of the 2014 King

County Buildable Lands Report in accordance with RCW 36.70A.215, which requires six western Washington

counties, including King County, and the cities within them, to measure their land supply and land capacity.

B. On July 23, 2014, the Growth Management Planning Council unanimously adopted Motions 14-4

recommending approval of the King County 2014 Buildable Lands Report.
