WHEREAS, the 2015/2016 Biennial Budget Ordinance, Ordinance 17941, Section 110, Proviso P3,							

states that \$250,000 of the appropriation for wastewater treatment shall not be expended or encumbered until

the King County executive transmits by March 1, 2015, a detailed work plan for utilizing an expert review panel for combined sewer overflow ("CSO") control projects and the wastewater conveyance and treatment system and a motion approving the plan, and

WHEREAS, in accordance with the proviso, the wastewater treatment division of the department of natural resources and parks has developed a work plan for utilizing an expert review panel to provide review and recommendations for CSO control projects and the wastewater conveyance and treatment systems;

NOW, THEREFORE, BE IT MOVED by the Council of King County:

The work plan on utilizing an expert review panel, which is Attachment A to this motion, is hereby approved, and the \$250,000 currently held in reserve through Ordinance 17941, Section 110, Proviso P3, is hereby released.
