AN ORDINANCE relating to the annexation of approximately 5.5 acres of land

into the North City water district, known as Ridgecrest Annexation 14-1, for the

purpose of water service.

STATEMENT OF FACTS:

1. A notice of intention proposing the annexation of approximately 5.5 acres of land into the North City water district, known as Ridgecrest Annexation 14-1, for the purpose of providing water service was filed with the county council on May 11, 2015.

2. North City water district has approved the proposed transfer subject to action by the

Boundary Review Board in Resolution No. 2015.04.07, passed on April 21, 2015.

- 3. The North City water district filed a determination of nonsignificance on the proposed annexation dated March 9, 2015.
- 4. The utilities technical review committee reviewed the North City water district's comprehensive plan, and found that plan meets the criteria for approval.
- 5. The county council held the legally required public hearing and has considered the criteria in RCW 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation of approximately 5.5 acres of land into the North City water district for the purpose of providing water service described in Attachment A to this ordinance is approved. Approval of this proposed annexation is consistent with RCW 57.02.040.

SECTION 2. The North City water district is the appropriate entity to serve the area proposed to be annexed.

SECTION 3. Completion of this annexation does not constitute county approval or disapproval of any other permits, certifications or actions necessary to provide service to this annexation area.
