AN ORDINANCE making a supplemental appropriation of \$8,925,000 and 21.50 FTEs to the department of public defense; and amending the 2015/2016 Budget Ordinance, Ordinance 17941, Section 49, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance 17941, Section 49, as amended, is hereby amended to read as follows:

PUBLIC DEFENSE - From the general fund there is hereby appropriated to:

Public defense
