BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. This ordinance makes a supplemental appropriation of \$483,000 to adult and juvenile

detention.

SECTION 2. Ordinance 17941, Section 48, as amended, is hereby amended to read as follows:
