SECTION 1. The collective bargaining agreement negotiated by and between King County and Washington State Council of County and City Employees, Council 2, Local 2084-FM (Department of Executive Services, Facilities Management Division) representing employees in the department of executive services, which is Attachment A to this ordinance, is hereby approved and adopted by this reference made a part hereof.
