#### STATEMENT OF FACTS:

1. The facilities management division received a request for space in June 2013 from the department of adult and juvenile detention community corrections division.

2. The department of adult and juvenile detention community corrections division needed space

for the operation of the community work program.

- 3. The facilities management division determined in May 2015 that there was not an appropriate county-owned option.
- 4. The facilities management division determined, through consultation with the department, that leasing was the most cost-effective option for the county.
- 5. The facilities management division successfully negotiated to lease space from Aleinikoff Investments, LLC, located at 925 Hiawatha Place South, Seattle, within council district two.

  BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The executive is authorized to execute a lease for the 925 Hiawatha

Place South with Aleinikoff Investments, LLC, substantially in the form of Attachment A to this ordinance, and to take all actions necessary to implement the terms of the lease.
