AN ORDINANCE authorizing the county executive to sign a twenty-five-year

lease enabling the Puget Sound Emergency Radio Network Project to occupy and

use a portion of the city of Bothell's Norway Hill communications site.

## STATEMENT OF FACTS:

- 1. King County has established a capital improvement project ("the PSERN project") to build the Puget Sound Emergency Radio Network ("PSERN").
- 2. King County adopted Proposition 1 and Ordinances 17993, 18074 and 18075, to fund the planning, deployment and testing of PSERN.
- 3. King County entered into a contract with Motorola Solutions, Inc., that requires Motorola to identify the sites needed for PSERN's communications equipment together with a list of equipment needed at each site. Motorola identified the city of Bothell's Norway Hill communications site as one of the needed sites.
- 4. The PSERN project, with the oversight of the county's Facilities Management Division, successfully negotiated a lease with the city of Bothell that would enable the PSERN project to use the Norway Hill site, located at 16206 104th Avenue NE, Bothell, Washington, in council district one.

## BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The executive is authorized to execute a lease for the Norway Hill site with the city of Bothell, substantially in the form of Attachment A to this ordinance, and to take all actions necessary to implement the terms of the lease.
