WHEREAS, the proviso response reports shall include, but not be limited to, a description of the department's limited English proficiency outreach efforts detailed in section IV of the report transmitted to

council by the department in June 2014 (2014-RPT0080) in response to Ordinance 17695, Section, and

WHEREAS, the director of elections has transmitted to the council its third report that contains the required information responding to the proviso, and

WHEREAS, the council has reviewed the department of election's report;
