BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The memorandum of agreement regarding Ferry Coalition Reopener on Cost-of-Living Adjustment for 2017, negotiated by and between King County and the Ferry Coalition (Passenger only Vessels, Marine Division, Department of Transportation) representing employees in the department of transportation, which is Attachment A to this ordinance, is hereby approved and adopted by this reference made a part hereof. The memorandum of agreement regarding Deckhand Bump-up to Captain, negotiated by and between King County and the Ferry Coalition (Passenger only Vessels, Marine Division, Department of Transportation) representing employees in the department of transportation, which is Attachment B to this ordinance, is hereby approved and adopted by this reference made a part hereof.

SECTION 2. Terms and conditions of the memorandum of agreement regarding Ferry Coalition Reopener on Cost-of-Living Adjustment for 2017, which is Attachment A to this ordinance, shall be effective from January 1, 2017, through and including December 31, 2017. Terms and conditions of the memorandum of agreement regarding Deckhand Bump-up to Captain, Attachment B to this ordinance, shall be effective prospectively after the agreement is approved by King County council and implemented in the payroll system, through and including December 31, 2017.
