AN ORDINANCE changing the name of the Lakehaven Utility District to the  
Lakehaven Water and Sewer District.

### STATEMENT OF FACTS:

1. The board of commissioners of the Lakehaven Utility District has determined that it would be in the best interests of the district to change its name to the "Lakehaven Water and Sewer District."
2. The district filed Resolution 2016-1273 with the metropolitan King County council on August 29, 2016, resolving to change the name of the district from Lakehaven Utility District to Lakehaven Water and Sewer District.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The metropolitan King County council approves the change in name of the district from Lakehaven Utility District to Lakehaven Water and Sewer District as set forth in RCW 57.04.065.
