AN ORDINANCE relating to the 2016 levy of property taxes in King County for

collection in the year 2017; and amending Ordinance 18440, Section 2,

Ordinance 18440, Section 3, and Ordinance 18440, Section 4.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance 18440, Section 2, is hereby amended to read as follows:

The metropolitan King County council imposes the tax levies necessary to fund estimated expenditures for the year 2017 as listed in this section. These amounts do not include the total of estimated revenues from sources other than taxation, including available surplus and such expenditures as are to be net from bond warrant issues. In accordance with state law, the King County assessor calculated a sum for property taxes
