AN ORDINANCE approving and adopting the collective bargaining agreement

negotiated by and between King County and Public Safety Employees Union

establishing the effective date of said agreement.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The collective bargaining agreement negotiated by and between King County and Public Safety Employees Union (Non-Commissioned Professional Employees - Supervisory - King County Sheriff's

Office) representing employees in the King County sheriff's office, which is Attachment A to this ordinance, is hereby approved and adopted by this reference made a part hereof.

SECTION 2. Terms and conditions of said agreement shall be effective from January 1, 2016, through and including December 31, 2016.
