AN ORDINANCE approving and adopting the collective bargaining agreement

negotiated by and between King County and Washington State Nurses

Association (Supervisors and Managers) representing employees in the

department of public health; and establishing the effective date of said agreement.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The collective bargaining agreement negotiated by and between King County and

Washington State Nurses Association (Supervisors and Managers) representing employees in the department of public health, which is Attachment A to this ordinance, is hereby approved and adopted by this reference made a part hereof.

SECTION 2. Terms and conditions of said agreement shall be effective from January 1, 2017, through and including December 31, 2019.
