A MOTION relating to parks and trails; acknowledging receipt of the first of three progress reports on the East Lake Sammamish Trail as required by the 2017-2018 Biennial Budget Ordinance, Ordinance 18409, Section 132, Proviso P1.

WHEREAS, in November 2016, via the 2017-2018 Biennial Budget Ordinance, Ordinance 18409, Section 132, Proviso P1, the King County council adopted and the executive approved, a proviso encumbering a total of three hundred thousand dollars in the capital improvement program, and requiring three progress reports on the East Lake Sammamish Trail project, and

WHEREAS, the encumbered funds may be expended in three increments of one hundred thousand

dollars after the executive transmits and the council approves each of the three reports which are due to the King County council on June 1, 2017, December 1, 2017, and June 1, 2018;

NOW, THEREFORE, BE IT MOVED by the Council of King County:
