A MOTION accepting a report describing a pretrial services pilot program for south King County in compliance with Ordinance 18409, Section 55, as amended by Ordinance 18602, Section 29, Proviso P4.

WHEREAS, a 2017-2018 Supplemental Budget Ordinance, Ordinance 18602, Section 29, Proviso P4, which amended the 2017-2018 Biennial Budget Ordinance, Ordinance 18409, Section 55, requires the executive to transmit a report describing a pretrial services pilot program for south King County, and a motion accepting the report, and

WHEREAS, Ordinance 18602, Section 29, Proviso P4, provides that \$500,000 shall not be expended or encumbered until the report required by the proviso is accepted, and the motion accompanying this reports is passed, and
