A RESOLUTION relating to the operations and finances of the King County

Flood Control Zone District; authorizing the expenditure of District funds for

WHEREAS, the King County Flood Control Zone District ("District") adopts an annual work program, budget, operating budget for King County, capital budget and six-year capital improvement program pursuant to chapter 86.15 RCW, and

WHEREAS, in 2014, the District created the Flood Reduction Grant fund to provide grant funding for projects with flood reduction benefits, including, but not limited to, surface water overflows, near shore flooding, lake flooding due to outflow blockage, or the clearance of clogged agricultural drainage systems, and

WHEREAS, the District desires to continue funding projects in the Flood Reduction Grant fund, and WHEREAS, in establishing the District's 2018 budget, the District provided \$3,192,994 in funding in

the Flood Reduction Grant fund, and

WHEREAS, a selection committee composed of the assistant director of the water and land resources division of the King County department of natural resources and parks, the District's executive director and a former Newcastle councilmember reviewed the 2018 applications for grant funds and made a recommendation regarding them to the District, and

WHEREAS, the District's executive committee reviewed the selection committee's recommendations, and

WHEREAS, based on the recommendation of the selection committee, as considered and modified by the District's executive committee, the board of supervisors desires to approve 2018 grant fund applications and projects;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE KING COUNTY FLOOD CONTROL ZONE DISTRICT:
