BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance 12917, Section 1, as amended, and K.C.C. 4A.640.010 are hereby amended to read as follows:

1. Program participants engaged in job search, who become unemployed while on the program, who are enrolled in educational programs, or who receive treatment while in the program will not be subject to a daily room and board rate.))

1. Program participants who earn \$15.01 per hour and over shall pay fees equivalent to the cost of the equipment ordered by the court, which includes both the equipment rental and the monitoring fees; and

2. Participants who earn \$15.00 per hour or less shall pay half of the cost of the equipment and fees, unless waived by the court.

((2. Out-of-county program participants shall be charged the same daily rate as charged to contracting agencies.

3. Should the net maintenance fee be lower than the daily room and board rate the net maintenance fee shall be the amount charged.

B. "Net maintenance fee" shall mean the fee that is calculated and established annually by the department of adult and juvenile detention according to the formula contained in contract for jail services between the county and the cities in King County. The department shall promptly file a statement of the fee

with the clerk of the council.))

<u>B.</u> Participants ordered to electronic monitoring from juvenile <u>court shall not be</u> required to pay fees under this section.

SECTION 2. This ordinance takes effect January 1, 2019.
