A MOTION acknowledging receipt of a report on the development of a new staffing and operations plan for the juvenile detention facility at the youth services center to accommodate in that facility youth charged as adults in compliance with Ordinance 18409, Section 55, as amended by Ordinance 18766, Section 23, Proviso P11.

WHEREAS, a 2017-2018 supplemental budget ordinance, Ordinance 18766, Section 23, Proviso P11, which amended the 2017-2018 Biennial Budget Ordinance, Ordinance 18409, Section 55, requires the executive to transmit a report on the development of a new staffing and operations plan for the juvenile detention facility at the Youth Services Center to accommodate in that facility youth charged as adults, and a motion acknowledging receipt of the report, and

WHEREAS, Ordinance 18766, Section 23, Proviso P11, provides that \$100,000 shall not be expended

or encumbered until the report required by the proviso is acknowledged, and the motion acknowledging receipt of this report is passed;

NOW, THEREFORE, BE IT MOVED by the Council of King County:
