AN ORDINANCE approving and adopting the Total Compensation Coalition Bargaining 2019-2020 memorandum of agreement negotiated by and between King County and Teamsters Local 174 and Washington State Council of County and City Employees, Council 2, Local 21DC representing employees in the departments of executive services, local services, natural resources and parks and district court; and establishing the effective date of the agreement.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The Total Compensation Coalition Bargaining 2019-2020 memorandum of agreement

negotiated by and between King County and Teamsters Local 174 and Washington State Council of County and City Employees, Council 2, Local 21DC representing employees in the departments of executive services, local services, natural resources and parks and district court, which is Attachment A to this ordinance, is hereby approved and adopted by this reference made a part hereof. Also as part of Attachment A to this ordinance, appended to the Total Compensation Coalition Bargaining 2019-2020 memorandum of agreement are the following supplemental agreements:

A. Memorandum of Agreement - King County Total Compensation 2019-2020 for Appendix 51 of the Master Labor Agreement Teamsters Local 174 Departments: Natural Resources & Parks, Transportation [160]; and

B. Memorandum of Agreement - King County Total Compensation 2019-2020 for Appendix 53 of the Master Labor Agreement Washington State Council of County and City Employees, Council 2, Local 21DC District Court - Wages [090];

SECTION 2. Terms and conditions of the Total Compensation Coalition

Bargaining 2019-2020 memorandum of agreement shall be effective from January 1, 2019, through and including December 31, 2020.
