AN ORDINANCE authorizing the executive to enter into the Agreement for Implementation of the Building 4Equity Program by and Between King County and 4Culture.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Findings:

A. The Building 4Equity program will contribute to the health, vibrancy, culture and welfare of the communities of the county.

B. The Building 4Equity program will contribute to King County's Equity and Social Justice Strategic Plan by focusing resources on improving the quality of life for residents whose race, place and income have persistently kept them unable to participate in a wide range of opportunities. The program will bring additional funds to groups in King County whose staff, boards and audiences historically

have faced difficulty accessing secure, long-term dedicated cultural spaces.

C. The execution of the Agreement for Implementation of the Building 4Equity Program by and Between King County and 4Culture is in the best interests of the county and its citizens.

SECTION 2. The executive is authorized to enter into the Agreement for Implementation of the Building 4Equity Program by and Between King County and 4Culture, substantially in the form of Attachment A to this ordinance.
