BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The memorandum of agreement regarding Rail Electrical Worker Apprenticeship negotiated by and between King County and International Brotherhood of Electrical Workers, Local 77 (Metro Transit Department) representing employees in the metro transit department, which is Attachment A to this

ordinance, is hereby approved and adopted by this reference made a part hereof.

SECTION 2. Terms and conditions of the agreement shall be effective upon adoption by King County ordinance and shall remain in effect until the implementation of the successor collective bargaining agreement to the January 1, 2015, through December 31, 2018, collective bargaining agreement.
