SECTION 1. Ordinance 18835, Section 44, as amended, is hereby amended as follows:

GENERAL FUND TRANSER TO DEPARTMENT OF COMMUNITY AND HUMAN SERVICES -

From the general fund there is hereby appropriated to:

General fund transfer to department of community and human services \$55,000
