WHEREAS, the 2021-2022 Biennial Budget Ordinance, Ordinance 19210, Section 129, Proviso P1, states that \$5,000,000 of the appropriation for "capital project 1139844, DLS URBAN UKC INVEST, shall not be expended or encumbered until the executive transmits a plan for a community-driven decision-making process to allow for an equitable allocation of resources for urban unincorporated area investments ("the participatory budget process") and a motion that should acknowledge receipt of the plan and a motion acknowledging receipt of the plan is passed by the council," and
