BE IT ADOPTED BY THE KING COUNTY BOARD OF HEALTH:

NEW SECTION. SECTION 1. There is hereby added to BOH chapter 2.15F a new section to read as follows:

Suspension. Due to the enactment Chapter 196, Laws of Washington 2008, and Chapter 155, Laws of Washington 2021, providing for a statewide system of regulation for the safe and secure collection and disposal of medicines through drug take-back programs operated and funded by drug manufacturers and administered by the state of Washington Department of Health, the operation and effect of this chapter is suspended until such time that the state ceases to provide that service.

NEW SECTION. SECTION 2. There is hereby added to BOH chapter 11.50 a new section to read as follows:

Suspension. Due to the enactment Chapter 196, Laws of Washington 2008, and Chapter 155, Laws of Washington 2021, providing for a statewide system of regulation for the safe and secure collection and disposal of medicines through drug take-back programs operated and funded by drug manufacturers and administered by the state of Washington Department of Health, the operation and effect of this chapter is suspended until such

time that the state ceases to provide that service.

SECTION 3. **Severability.** If any provision of this rule or its application to any person or circumstance is held invalid, the remainder of the rule or the application of the provision to other persons or circumstances is not affected.
