In recognition of the fact that committee agendas may have previously been issued for meetings occurring during the week this motion is adopted, any committee for which the regular meeting day or time is changed herein that is holding a meeting this week shall meet at its previously adopted regular meeting day and time. The new regular

meeting day and time for such committees shall become effective the week following adoption of this motion.
