AN ORDINANCE relating to approval of the Work Plan for Avian and Pandemic

Flu Response.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Findings:

A. Ordinance 15597, Section 1, which amended Ordinance 15333, Section 81, declared that \$800,000 shall not be expended or encumbered until the executive transmits and the council adopts an ordinance approving a plan for how the \$4,760,000 of this appropriation previously allocated through Ordinance 15348 for the purchase of antiviral medications shall be expended. The plan shall be filed by December 4, 2006.

B. In accordance with Ordinance 15597, Section 1, which amended Ordinance 15333, Section 81, the
