WHEREAS, the responsibilities for the operating budget, fiscal management and mental health committee include: reviewing and monitoring the budget; monitoring the financial status of county funds; and considering and making recommendations to all supplemental appropriations, debt and investment proposals, levies, fees, taxes, municipal annexations and incorporations and on all briefings and actions related to Motion

12320 regarding mental health, chemical dependency and therapeutic court services and the mental health recovery plan, and

WHEREAS, in order to manage these responsibilities, facilitate the running of meetings and provide predictability regarding how business will be conducted, the committee chair has developed procedures, and

WHEREAS, these procedures will neither supercede nor supplant council rules and procedures as detailed in Ordinance 15668, Motion 12429 or K.C.C. chapter 1.24, and

WHEREAS, the committee seeks full council support for its procedures;
