AN ORDINANCE making a supplemental appropriation of \$267,920 from the

current expense fund to the prosecuting attorney's office to implement the King

County Prosecuting Attorneys Association collective bargaining agreement for

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an ordinance making a supplemental appropriation

of \$267,920 from the current expense fund (salary and wage contingency) to the prosecuting attorney, to

implement the King County Prosecuting Attorneys Association collective bargaining agreement.

SECTION 2. Ordinance 15652, Section 37, as amended, is hereby amended by adding thereto and inserting therein the following:
