AN ORDINANCE approving and adopting the collective bargaining agreement, one memorandum of understanding and two memoranda of agreement negotiated by and between King County and Joint Crafts Council, Construction Crafts representing employees in the departments of executive services, transportation, natural resources and parks, adult and juvenile detention, community and human services and public health; establishing the effective date of said agreements.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The collective bargaining agreement, one memorandum of understanding and two

memoranda of agreement negotiated between King County and Joint Crafts Council, Construction Crafts

representing employees in the departments of executive services, transportation, natural resources and parks, adult and juvenile detention, community and human services and public health and attached hereto are hereby approved and adopted by this reference made a part hereof.

SECTION 2. Terms and conditions of said agreements shall be effective from January 1, 2006, through and including December 31, 2008.
