WHEREAS, King County is dependent on a strong fiscal partnership with the federal government for transportation, public health, homeland security, salmon recovery, flood control, affordable housing and other important needs, and

WHEREAS, if King County is going to be able to continue delivering basic government services to our residents, it needs a preservation, if not an expansion, of federal support, and
