WHEREAS, the King County council and the King County executive have worked to develop a state legislative agenda and desire to bring their positions on state legislative issues to the attention of the 2008 Washington state Legislature, and

WHEREAS, King County desires to work cooperatively with other local governments and other organizations such as the Washington State Association of Counties, the Washington Association of County Officials, the Suburban Cities Association, the Association of Washington Cities and the Washington Transit Association to achieve its 2008 legislative goals, and

WHEREAS, counties have been recognized by the Legislature as partners with the state in the delivery of such critical services as public health, transportation, criminal justice, community and human services, and

WHEREAS, King County is dependent on a strong fiscal partnership with the state, and

WHEREAS, if King County is going to be able to continue delivering basic government services to our residents, it needs a preservation, if not an expansion, of state support, and

WHEREAS, the King County council and the King County executive will continue to review legislative developments for possible revisions of King County's 2008 state legislative program;
