AN ORDINANCE concurring with the recommendation of the hearing examiner to approve, subject to conditions, reclassification of certain property located at 19506 Vashon Highway Southwest, Vashon, as described in department of development and environmental services file no. L08TY402 from R-1-SO (Residential, one dwelling unit per acre within a Special District Overlay area) to CB-P-SO (Community Business-P-SO), at the request of Loren Sinner, and amending King County Title 21A, as amended, by modifying the zoning map to reflect this reclassification.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. This ordinance adopts and incorporates the findings and conclusions of the August 21, 2009, report and recommendation of the hearing examiner, filed with the clerk of the council on September 9, 2009, upon the application of Loren Sinner to reclassify certain property described in department of

development and environmental services file no. L08TY402.

SECTION 2. The recommendation of the hearing examiner to reclassify the subject property from R-1-SO to CB-P-SO is hereby adopted, subject to conditions. Upon this ordinance becoming effective, the land use services division shall amend the official zoning maps of King County to reflect this action.
