BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. From the general fund there is hereby approved and adopted a supplemental appropriation of \$345,451 to internal support; from the telecommunications fund a supplemental appropriation of \$1,046,822 to oirm - telecommunications to rebate equipment replacement charges collected primarily in 2007 to replace
