BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The collective bargaining agreement negotiated between King County and Public Safety

Employees Union (Non-Commissioned - Department of Community and Human Services) representing employees in the department of community and human services and attached hereto is hereby approved and adopted by this reference made a part hereof.
