BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The collective bargaining agreement and two memoranda of agreement negotiated between King County and International Federation of Professional and Technical Engineers, Local 17 (Supervisors) representing employees in the department of executive services; department of natural resources and parks; and, the department of transportation and attached hereto are hereby approved and adopted by this reference made a part hereof.

SECTION 2. Terms and conditions of said agreements shall be effective from January 1, 2009, through and including December 31, 2011.
