BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The collective bargaining agreement and memorandum of agreement negotiated between King County and Technical Employees Association (Wastewater Treatment Division) representing employees in the department of natural resources and parks and attached hereto are hereby approved and adopted by this reference made a part hereof.

SECTION 2. Terms and conditions of said agreements shall be effective from July 1, 2008, through and including December 31, 2010.
