AN ORDINANCE approving and adopting the Coalition Labor Agreement negotiated by and between King County and the King County Coalition of Unions representing employees in the departments of adult and juvenile detention, community and human services, elections, executive services, judicial administration, information technology, natural resources and parks, local services, public defense, public health, sheriff's office and metro, and the assessor, council, district court, superior court, and office of the prosecuting attorney; and establishing the effective date of the agreement.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The Coalition Labor Agreement negotiated by and between King County and the King County Coalition of Unions representing employees in the departments of adult and juvenile detention, community and human services, elections, executive services, judicial administration, information technology, natural resources and parks, permitting and environmental review, public defense, public health, sheriff's office and metro and the assessor, council, district court, superior court, and office of the prosecuting attorney, which is Attachment A to this ordinance, is hereby approved and adopted by this reference made a part hereof.
