AN ORDINANCE increasing the fee for nonidentifying adoption searches

performed by the family court services division of King County superior court as

authorized by RCW 26.12.220; and amending Ordinance 14791, Section 2, and

K.C.C. 4.72.026.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. A. Section 2 of this ordinance proposes changes in the fees charged for nonidentifying

adoption searches performed by the superior court.

B. The fee is authorized under RCW 26.12.220.

SECTION 2. Ordinance 14791, Section 2, and K.C.C. 4.72.026 are each hereby amended to read as

follows:

The superior court is hereby authorized to charge a flat fee of ((thirty)) sixty

dollars for each nonidentifying adoption search performed.

SECTION 3. This ordinance takes effect January 1, 2011.
