projects by February 1, 2012.

WHEREAS, K.C.C. 2.16.0757 establishes specific requirements for an annual technology business plan to be transmitted each year along with the executive's proposed budget, and

WHEREAS, the purpose of this technology business plan is to provide the council with information in one location on all of the technology projects requesting funding in the budget and to report on the cost savings achieved from existing and projected cost savings for new projects, and

WHEREAS, this year's Technology Business Plan that was submitted did not meet the requirements in

K.C.C. 2.16.0757 and the budget and fiscal management committee requested that the executive transmit a revised Technology Business Plan, and

WHEREAS, the revised Technology Business Plan, which is Attachment A to this motion, has been transmitted and does not contain a report on cost savings achieved from existing and new projects as required in K.C.C. 2.16.0757, and

WHEREAS, the executive has requested additional time to report on cost savings for existing and new projects;

NOW, THEREFORE, BE IT MOVED by the Council of King County:

- A. Attachment A to this motion, the 2012 Technology Business Plan is adopted.
- B. The executive is requested is transmit, by February 1, 2012, a report on cost savings achieved for new and existing projects, in the form of a paper original and an electronic copy with the clerk of the council, who shall retain the original and provide

and electronic copy to all councilmembers, the council chief of staff and the lead staff for the government accountability and oversight committee or its successor.
